Proof of identity and current residence is required to be able to vote in municipal elections. Any of the following documents that has your name and address on it will be accepted as valid proof:

- Photo identification issued by a Canadian government or agency, whether federal, provincial or local;
- Bank/credit card statement or personal cheque;
- Correspondence issued by a school, college or university;
- Government cheque or cheque stub;
- Income/property tax assessment notice;
- Insurance policy or coverage card;
- Letter from a public curator, public guardian or public trustee;
- Pension Plan statement of benefits, contributions or participation;
- Residential lease or mortgage statement;
- Statement of government benefits: e.g. Employment insurance, old-age security, social assistance, disability support, or child tax benefit;

- Utility bill: e.g. Telephone, public utilities commission, television, electricity, gas or water;
- Vehicle ownership, registration or insurance certificate; or
- A letter or form (attestation) confirming that the person lives at the stated address. The letter can be signed by any of the following:
 - authorized representative of a commercial property management company;
 - authorized representative of a correctional institution;
 - authorized representative of a First Nations band or reserve;
 - authorized representative of a post-secondary institution;
 - authorized representative of a facility that provides services to the homeless; or
 - authorized representative of a supportive living facility or treatment centre;

as required by section 53 of the *Local Authorities Election Act*.

Notice of Special Ballot

Local Authorities Election Act

Section 77.1 & 77.2

Local Jurisdiction:

Town of Morinville, Province of Alberta

Notice is hereby given that any Elector who is unable to vote at an advance vote or at the voting station on election day because of: physical incapacity, absence from the local jurisdiction or being a returning officer, deputy returning officer, constable, candidate or agent who may be located on election day at a voting station other than that for the elector's place of residence, may apply for a Special Ballot package.

Electors must apply for Special Ballot packages by completing the "Request for Special Ballot Package" and submitting the form to the Returning Officer. Packages must be requested from the Returning Officer to allow enough time for the Special Ballot package to reach the elector and to be returned to the Returning Officer before the close of the voting station on election day. The "Request for Special Ballot Package" is available on the Municipality's website at www.morinville.ca/election.
